Dear Mr. Schwab,

Thank you for contacting me about healthcare policy. I appreciate you taking the time to write and share your perspective. It is an honor to serve you in the United States House of Representatives. I hope you will continue to write with your thoughts and ideas for moving our country forward.

Rural Coloradans face significant obstacles in accessing healthcare. Federal bureaucracy, lack of telehealth availability, and limited marketplace competition increase prices for rural Americans. By cutting red tape, we can drastically expand healthcare services and cut costs in rural areas.

I cosponsored the Rural Health Clinic Location Modernization Act to expand the definition of a rural health clinic under Medicare, increasing access to primary and preventive care services in rural communities. As part of the Working Families Tax Cut passed in July, I voted to secure \$50 billion in funding for rural hospitals and health care providers. I stand with President Trump in Making America Healthy Again, including holding drug companies accountable. I cosponsored the End the Vaccine Carveout Act to remove civil liability protections for vaccine manufacturers, providing potential victims of Big Pharma a pathway to restitution.
